### Assistance with Daily Life Tasks in a Shared Living Arrangement

Assistance in Supported Independent Living (SIL)

Support provides assistance with, or supervision of, tasks of daily life in a shared living environment, with a focus on developing the skills of each individual to live as autonomously as possible.

SIL does not include rent, board and lodging or other day-to-day usual living expenses such as food and activities. It also does not include the capital costs associated with a participant's accommodation.

A provider/participant will either use the Hourly SIL support items or the Weekly SIL support item, but not both methods.
