### Assistance with Daily Life Tasks in a Shared Living Arrangement

Assistance in Supported Independent Living (SIL)

Support provides assistance with, or supervision of, tasks of daily life in a shared living environment, with a focus on developing the skills of each individual to live as autonomously as possible.

SIL does not include rent, board and lodging or other day-to-day usual living expenses such as food and activities. It also does not include the capital costs associated with a participant's accommodation.

A provider/participant will either use the Hourly SIL support items or the Weekly SIL support item, but not both methods.

**Assistance in Supported Independent Living**

**Hourly claiming (Standard)**

The Hourly support items are subject to the price limits as set out below. Different price limits apply depending on the Time of Day and Day of Week on which the support is delivered.
